## 2006 SCL Forum News

### CALL FOR SCORES

The Southeastern Composers League 2006 Annual Forum will take place at the Carroll McDaniel Petrie School of Music at Converse College on March 16-18. [Directions to the College can be found on page 6. Additional hotel information will be sent in a supplemental email]

SCL members are encouraged to submit up to three works for performance consideration. The emphasis of this year's forum will be upon solo and chamber works—no large ensembles will be participating.

Of particular interest are works for the newly formed faculty ensemble, **Conversant**, a faculty sextet comprising flute, oboe, violin, cello, and two pianos.

Other performing groups that have expressed interest in being included on the forum include...

**The Converse Trio:** faculty piano trio

**Ensemble Radieuse:** faculty trio of flute, oboe, and piano

**Student wind quintet:** flute, oboe, clarinet, bassoon, and horn

**The Araya Quartet:** student string quartet

Graduate student piano trio

**Piano Team:** student group of 4 (perhaps more) pianists

Additionally the college can offer most standard orchestral instruments, as well as all voice types. In addition to works for small combinations of voices, composers might consider submitting works for the **Converse College Chamber Singers**, a small (approx. 12 voices) select SSA ensemble. Works requiring electronic playback are also a possibility.

And, of course, composers are welcome (even encouraged) to bring their own performers. Please include contact information (telephone numbers and email address), as well as whether you are able to provide performers.

Dorothy Hindman

**Dorothy Hindman** and her husband **Charles Norman Mason** are spending the year in Rome after Chuck won the Rome Prize. They recently finished a residency in Sweden at the Visby International Centre for Composers. Dorothy's composition **Time Management** was performed by bassist Jeremy Kurtz in June at the International Society of Bassists Convention, held at Western Michigan University, Kalamazoo, MI. **Time Management** was the 2004 Winner of the International Society of Bassists Solo Composition Competition. This was the official world premiere of the work.

## Calls for Scores and Competitions

### ROBERT HELPS PRIZE

**Prize:** \$10,000 will be awarded to the composer of the winning composition

**Performance:** The winning composition will be performed in Tampa on February 14, 2006 and in New York City (Merkin Recital Hall) on February 18, 2006

**Application Fee:** \$15 in US funds shall be included with all applications.

**Instrumentation for 2006 Competition:** Trio: Piano, Violin, Violoncello.

**Deadline:** Scores and application materials must be received on or before October 14, 2005.

**How to apply:** Submit three copies of full score, (MIDI or rehearsal recordings are encouraged) a copy of birth certificate or passport indicating that the applicant shall not have reached the age of 36 by February 14, 2006, application fee, and application form.

### NATS 2006 ART SONG COMPOSITION AWARD

**Awards** - 1st place - \$1,000 plus the composer's expenses to the NATS National Conference in Minneapolis, July, 2006, where the premiere performance of the winning composition will be given. 2nd place - \$500

**Requirements** - The work must be: (1) a song cycle, group of songs, or extended single song of approximately fifteen minutes in length (13-17 minutes acceptable); (2) for single voice and

piano; (3) to a text written in English, for which the composer has secured copyright clearance (only text setting permission necessary); (4) composed within the last two years (after Jan. 1, 2004).

**Entry Fee** - \$30 for each entry (payable in U.S. funds to NATS).

**Eligibility** - Anyone meeting prescribed requirements.

## President's Message

When summer ended, it brought not only the beginning of a new semester but also a new life for many in the southeast. The hurricane's eye came very near, if not over, **Jerry Sieg's** home in Slidell, Louisiana and his home is in terrible condition. According to Jerry, "we have trees on the roof and had more than six feet of water in the house. We visited the house Wednesday (9/7) and it was a horrible experience. Everything inside is destroyed. I lost all books, recordings, scores, manuscripts....but we are thankful we have our lives..." If any of you have copies of Jerry's compositions, please contact him at [alsjps@bellsouth.net](mailto:alsjps@bellsouth.net). He left before the hurricane struck and is currently living in Florida.

**Ken Davies** also escaped to Florida before the hurricane hit his home in Gautier, Mississippi. In Ken's words, "The entire Mississippi coast is trash for 6+ blocks inland. Most businesses in nearly all towns were along the coastline and no longer exist except in memory and rubble, taken out by the 25+ foot wave and storm surge. Churches and stately homes just disappeared." Ken has now gone back to salvage as much as possible....drying what he can by hanging items on a clothesline. Like Jerry, he lost many books, tapes and reference materials. His main concern, however, is finding a job. According to Ken, "We know that independent (non-school) music is economically dead on the coast for quite a while. We had been awarded some arts grants but now can't do anything with them. If any members know of a college who would take a composer with an MA in trombone and an MM in composition to teach theory, music appreciation, composition, low brass, music business or do administrative work, I'd sure appreciate knowing where we might relocate." Until his phone (228-522-0028) is fully operational, please call Judy (660-668-2274) and she will relay your message to him. If this event were not traumatic enough by itself, consider Judy's comments: "This is the fourth time we have had to evacuate in less than three years, so we are anxious to relocate to an area that is not susceptible to hurricanes."

If you're like me, you've often take things for granted. Let's use this disaster to remind us to be grateful not only for successes and honors, but also for the basic necessities of life.

**CONTEST RULES**

1. Student composers who submit compositions to either the Salop or Slates Composition Contest must either (1) study with a person who is a member of SCL, or (b) be a student member of SCL.
2. Both contests are limited to works for 8 performers or fewer. Recordings (CD or cassette) are not required, but much appreciated. Each work submitted must be an original musical composition which has received no previous award.
3. All contestants must be full-time students in conservatories, colleges, or universities within the area represented in the Southeastern Composers' League: Delaware, Maryland, Washington, DC, Virginia, West Virginia, North and South Carolina, Tennessee, Kentucky, Georgia, Alabama, Florida, Louisiana, Mississippi, and Arkansas. The Arnold Salop Contest is limited to undergraduate students, and the Philip Slates Contest is limited to graduate students. Student composers who submit compositions to either the Salops or Slates Composition Contest must either (a) study with a person who is a member of SCL, or (b) be a student member of SCL. There are no other curricular or age restrictions.
4. A first place award of \$150 and a second place award of \$100 will be made in each contest. Winners will be announced at the SCL Annual Forum and the winning compositions will be considered for performance on the Forum program the following year. Only one submission per student is allowed, and the judging panel reserves the right to grant no award. Should no entry be considered worthy of an award, none will be given.
5. Four (4) copies of each entry (score and recording) must be submitted. Each entry must be accompanied by (A) a copy of the completed entry blank below, and (B) a stamped, self-addressed envelope suitable for returning materials to the contestant. The Southeastern Composers' League assumes no responsibility for damage to scores and tapes in transit. Do not submit the only remaining copy of any score.

In case it doesn't open, this is what the relevant text states:

From Charlotte, NC

1. Take I-85 SOUTH towards Gastonia NC (you will stay on I-85 South all the way to Spartanburg, SC).
2. From I-85 take exit 77 (Business 85 south to Spartanburg).
3. Take the I-585/US176 EAST exit (exit number 5A) towards PINE STREET/DOWNTOWN. (I-585/US176 will turn into Pine Street.)
4. After 4 miles, turn left onto ST. JOHN STREET.
5. At the next light turn LEFT onto EAST MAIN STREET.
6. At the next light turn LEFT into the main entrance of Converse.

From Atlanta, GA and Greenville-Spartanburg Airport

1. Take I-85 NORTH towards (you will stay on I-85 North all the way to Spartanburg, SC).
2. Take the I-85 Business Loop NORTH exit (exit number 69).
3. Take the I-585/US176 EAST exit (exit number 5A) towards PINE STREET/DOWNTOWN. (I-585/US176 will turn into Pine Street.)
4. After 4 miles, turn left onto ST. JOHN STREET.
5. At the next light turn LEFT onto EAST MAIN STREET.
6. At the next light turn LEFT into the main entrance of Converse.

From Columbia, SC

1. Take I-26 WEST towards Spartanburg, SC (you will stay on I-26 West all the way to Spartanburg, SC).
2. From I-26 WEST, take exit 22. Turn RIGHT off the exit towards Spartanburg and follow this road (called Reidville Road) for 5 miles.
3. Reidville Road becomes St. John Street after crossing West Main Street.
4. Follow St. John Street until it ends at EAST MAIN STREET. Turn LEFT onto EAST MAIN STREET.
5. At the next light turn LEFT into the main entrance of Converse.

From Knoxville, TN

1. Take I-40 EAST until you reach Asheville, NC.
2. Take the I-26 EAST exit (exit number 46A) towards HENDERSONVILLE and SPARTANBURG.
3. Take the Highway 176 Inman exit (exit number 15). Follow signs to Spartanburg.
4. US Highway 176 will turn into Pine Street.
6. At the 8th light turn left onto ST JOHN STREET.
7. At the next light turn LEFT onto EAST MAIN STREET.
8. At the next light turn LEFT into the main entrance of Converse.
