- Call to Order (1:03 PM)
- Approval of minutes from December 1, 2023 meeting
- Guest: Dr. Danette Beane, VP for Enrollment Management and Strategic Communication Announced decision to change admission systems from CollegeNet to Slate, the system currently used for undergraduate admissions;
 - Change should allow greater integration between CAS's (used by DPT, PA, MOT, COSD, MSAT), and more support from Enrollment Management for graduate admissions processing and recruitment. Change should allow elimination of supplemental application. CAS applicants will not be charged an additional application fee as before
 - Dr. Hilden asked if the application fee would be removed in general? ANS: fee will remain for all programs except CAS application programs (listed above)
 - Dr. Trent asked if there would be a change in out-of-state tuition waivers. ANS: Dean Caldwell indicated current fee waiver pool of funds should remain in place. No indication of change to that source of funds. Requests for out-of-state waivers should be made to Michele Ralston as has been done in the past.
 - Also announced that admissions and recruitment personnel from Grad College would be moving under Enrollment Management
 - Dr. Beane also discussed website redesign: After March 11, <u>no changes</u> will be made to the web site. All web resources will be targeted at finalizing the new website design efforts. Only changes made before March 11 will be incorporated into the new website.

 - Curriculum Deadlines:
 - Feb 1 final launch date for proposals requiring SCHEV approval
 - March 18 final launch date for all others
 - Spring Enrollment:
 - 1388 up 88 students YTD from 2023 (+6.8%)

- Interim Associate Dean Manizade mentioned that the deadline for application for Graduate Student Awards had closed
 - Applications for Highlander Research Blitz Competition will be taken until Feb 19th. She asked GAC members to encourage their students to apply by submitted sample videos. Finalists for the April 3 competition would be made in March.
 - Graduate Studen Appreciation week will be held April 1-5. Events will be held on main campus and at RUC
- Old Business
 - Bylaws
 - GAC representative options See Table 1 (attached)
 - Discussion at Dec GAC raised a concern over the large size of the council as proposed in the draft bylaws – one rep per degree or program
 - Dean Caldwell indicated that draft of bylaws had been discussed with the Provost. He described the Provost's concern about the relatively large number of faculty proposed, and asked if a smaller number could be choses to not dedicate so much faculty time to the council.

Dean Caldwell Presented Table 1 showing possible models for member representation (summarized below

- By Degree offered 27
- By program 48
- By Department/School 18

Discussion

- Current practice has allowed each program/concentration to have a representative. For department with multiple degrees or programs/concentrations, a single faculty member may act as a representative (still only one vote per rep). Ex. Psychology has two programs (I/O & Experimental) but only one representative (J. Steele) may not all programs. Health Science has both MS and DHS degrees but only one rep.
- It was discussed that some department with multiple programs would be allowed multiple reps which could become a large voting block – examples could include College of Nursing and STEL
- Several members stated that there are rarely controversial or contentious issues brought the GAC; GAC member have trust their colleagues to manage their programs, but also to be good stewards of policies and curriculum. Most votes are nearly always unanimous.
- Many council members indicated single representation by departments could work, and would be less taxing on faculty demands.
- Dean Caldwell said he would bring the matter to the Bylaws committee for further discussion.

ACADEMIC COURSE AND PROGRAM REVIEW

1. Criminal Justice

A. Course Revision Proposals

- CRJU 672 Remove pre-requisite CRJU 670 (course being deleted), update catalog description and course title to more accurately reflect course content. Current title: Applications in Crime Analysis
 - New Title: Crime Analysis and Criminal Intelligence
- 2. **CRJU 673** Update catalog description and revise course name. New Title: Crime Mapping
 - New Title: Crime Mapping and Spatial Analysis in Criminal Justice
- 3. **CRJU 676** revise catalog description to more accurately reflect course content.

B. Program Revision Proposals

- 1. **Crime Analysis Certificate** reduce total credits from 15 to 12 to assist student in time to completion, program cost and align with other Crime Analysis certificate programs. Removes CRJU 670 Research Methods course.
- 2. Criminal Justice, M.S. reduce program from 36 to 30 credits to align with other similar programs in the state; New program design will allow full time students to complete the program in one calendar year

C. Program Deletion Proposal

1. Criminal Justice, M.A – with reduction in credit hours from 36 to 30 credits for the master's program, the thesis requirement is being eliminated. M.A. degree will no longer needed.
