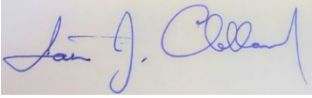

Entrepreneurship Minor (15 Semester Hours)

The minor in **entrepreneurship** is designed to provide students with the complementary skill sets needed to effectively create and manage business opportunities associated with their primary discipline (e.g., art gallery, boutique, online music business, health clinic, professional services practice, private security agency, technology start-up, non-profit social services). The requirements for completion of the entrepreneurship minor are as follows:

➤ Required Courses: 9 Hours:

- **ENTR 240** Social Entrepreneurship (3) Prerequisite: None **OR** **ENTR 250**. Innovation & Entrepreneurship (3) Prerequisite: None
- **ENTR 350**. Managing New Venture Creation (3) Prerequisite: **ENTR 240** or **250**
- **ENTR 425**. Entrepreneurial Leadership (3) Prerequisite: None **OR** **ENTR 450**. Owning & Managing Your Own Business (3) Prerequisite: None

➤ Electives - Disciplinary Cluster Courses: 6 Hours

In addition to the 9 credits listed above, students are required to take 6 Undergraduate courses in your discipline that: (1) are 300/400 level, (2) employ applied/experiential pedagogy (not lecture-based), (3) have some entrepreneurship content, and (4) completed prerequisite ENTR 240 or 250. These can be pre-approved by the Department of Management Chair for efficient advising.

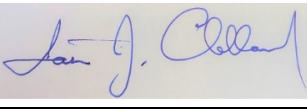
