Admission to Radford University is selective and based on a review of each applicant's academic qualifications. The University selects students who present the strongest qualifications in scholastic achievement, character, and performance in extracurricular activities. The Office of Admissions will have two primary notification dates depending on the date the application is complete in the Admissions Office. Students who are interested in applying Early Action must submit a complete application by December 1st and will be notified of the admissions decision by January 15th. Applicants who apply by the Regular Decision date of February 1st will be notified of the admissions decision by April 1st. Students who do not meet the February 1st date may still apply to the University until April 1st. However, these applications will be considered if space is available, and decisions will be mailed on a rolling notification basis.

Some of the questions asked on the application are important to the University in creating students' records and in completing federal and state reports. Failure to answer any of the questions may delay action on your application.

The application has been designed to comply with the Privacy Protection Act. We request your Social Security number to use as your student identification number. If you choose not to provide it, we will assign you a number to use when your student number

is required. Please note: To be eligible to receive Financial Aid, you must supply your Social Security number.

Freshman Admission

To be considered for admission, an incoming freshman should . . .

1. Complete a broad selection of coursework in high school. Past successful applicants have taken at least: 4 units of English, 4 units in college preparatory math (math must include Algebra I & II and Geometry), 4 units in laboratory science, 4 units in social studies (including American history), and 3-4 units of a foreign language.

2. Complete the formal application and the Request for High School Transcript form and submit these items along with the non-refundable application fee of \$50 to your high school counselor. It is recommended that all application materials be sent to Radford directly from the high school. Your transcript should not be submitted until completion of your junior year. We prefer to receive transcripts which include the first grading period of the senior year. Enrollment in college courses before completing your high school diploma is not basis for classification as a transfer applicant. However, if you have taken college courses, please have official transcripts of all work attempted forwarded to the Office of Admissions in addition to your high school transcript.

3. Take the Scholastic Assessment Test I (SAT I) or the American College Testing Assessment (ACT). We recommend that this

test be taken in April of your junior year but no later than December of your senior year. Your test results should be sent to the Office of Admissions. RU's school code for the SAT I is 5565; ACT code is 4422.

Transfer Admission

Transfer applicants will be considered on the basis of previous college performance. A minimum C cumulative grade point average (2.0 on a 4.0 scale) on **all work attempted** is required for consideration.

A transfer student must . . .

1. Complete and return the formal application with the nonrefundable application fee of \$50.

2. Request that the Registrar send official transcripts of all college work through the last semester or quarter completed. **Transcripts from all previous colleges attended must be sent to the Office of Admissions for evaluation whether or not transfer credit was earned or is desired.** If you have withdrawn from a college, a transcript indicating "W" in all coursework must be submitted.

3. If you have completed fewer than 24 semester hours, you must submit a final high school transcript. Your high school performance will be considered as part of the admission process and you must meet the freshman admission guidelines.

You should also send your high school transcript if you have not successfully completed a transferable college-level math course.

ADVANCED PLACEMENT, CLEP, AND INTERNATIONAL BACCALAUREATE

The University gives credit to entering students for certain college-level courses taken while in high school or for proficiency acquired. Credit is based on the results of tests administered through the Advanced Placement, College Level Examination, and International Baccalaureate programs. The exams and scores accepted by the University are available on our online undergraduate catalog.

ACCEPTANCE NOTIFICATION

Upon receipt of the letter of acceptance as a residence hall student, all applicants must submit a room reservation deposit and a tuition deposit. The deposits for fall semester are refundable if requested in writing and postmarked on or before May 1. After May 1, these deposits will be accepted only if space is available. Because room assignments are made according to the date on which the deposit is received, it is to your advantage to confirm your acceptance as quickly as possible. Room deposits and tuition deposits for spring and summer terms are nonrefundable.

Upon receipt of the letter of acceptance as an off-campus student, all applicants must submit the Off-Campus Student Contract and the tuition deposit. This deposit is refundable if requested in writing and postmarked on or before May 1. After May 1, deposits will be accepted only if space in the class is available. Tuition deposits are nonrefundable for spring and summer terms.

IN-STATE TUITION

To be considered for in-state tuition, you must complete the Application for In-State Tuition which is included with the Application for Admission. If you wish to apply for in-state tuition after your enrollment, you must submit the appropriate application form prior to the first day of classes for the term you are seeking in-state status. The form is available in the Office of Admissions.

BOARDING POLICY

All new freshmen are required to live in University residence halls unless they qualify for off-campus housing status. (Please see the Boarding Policy in the Undergraduate Catalog.) New freshmen who are admitted as

off-campus students must reside with their parents, guardians, or relatives 21 years of age or older who are permanent residents within commuting distance of the university.

SCHOLARSHIPS

The Radford University Foundation funds the Radford Scholars Program, which recognizes outstanding high school achievement by awarding non-need based scholarships to incoming freshmen on a competitive basis. The Office of Admissions identifies eligible students on the basis of their admission credentials and contacts them individually. The Office of Admissions must have your completed application for admission by January 15.

CITIZENSHIP

U.S. Citizen or National — a person born in the United States or with U.S. citizenship.

Resident Alien — a person not a citizen or national of the United States who has been lawfully admitted for permanent residence in the United States and holds a “green card.”

Non-Resident Alien — a person in this country on a temporary basis who does not have the right to remain indefinitely. Example: an individual in this country pursuing a course of study or performing temporary services.

RACE/ETHNIC BACKGROUND

These questions are required so that we may comply with Title VI of the Civil Rights Act. The descriptions below are designated by the Office of Civil Rights for reporting purposes:

White, Non-Hispanic — a person having origins in any of the original peoples of Europe, the Middle East, or North Africa.

Native Hawaiian or Other Pacific Islander — a person having origins in any of the original

peoples of Hawaii, Guam, Samoa, or other Pacific Islands.

American Indian or Alaskan Native — a person having origins in any of the original peoples of North and South America (including Central America) and who maintains tribal affiliation or community attachment.

HONOR CODE

Radford University operates under an honor system which provides the foundation for a college community in which freedom, trust, and respect can prevail. If available aid is not sufficient to meet the full financial need of all applicants, awards are made first to those who demonstrate the greatest need and who meet the FAFSA filing deadline of February 15.
